**As a former federal law clerk with an impeccable eye for detail, Andrew “Drew” Robertson lends his ample legal knowledge and abilities to KRCL’s commercial litigation and appellate teams.**

He finds it gratifying to untangle the legal threads, distill the issues into a straightforward and understandable theory of the client’s case, and then craft the best strategy for persuading the court that the facts and applicable law support that theory.

Cummings in the Northern District of Texas, where his responsibilities included helping manage the Court’s extensive civil docket, researching legal issues in cases before the Court, and drafting and editing hundreds of opinions and orders. This experience gave him an in-depth understanding of federal rules and procedure, and the firm’s attorneys routinely draw on Drew’s extensive knowledge of that subject to help clients navigate the advantages and potential pitfalls of litigating in federal court.

Drew previously spent time interning for Senator John Cornyn (TX) in the United States Senate and in the Tarrant County Criminal District Attorney’s Office.
